Message from **Chairman**

A warm welcome to this edition of the RAK Quarterly Newsletter.

REITs Association of Kenya (RAK) is continuously working towards growing the REITs market in Kenya, through various initiatives which you will read about in this edition.

2018 marked the Association's first fully operational year, during which we achieved a number of milestones. Firstly, RAK signed a Memorandum of Understanding (MoU) with United States based National Association of Real Estate Investment Trusts (NAREIT) which is focused on co-operation between the 2 parties' on mutually beneficial areas. The Association also had its inaugural REITs conference in September 2018, which brought together over 250 delegates. Additionally, RAK has been recognized by the Capital Markets Authority and Retirements Benefits Authority as the formal representative of REITs in Kenya.

Going forward, we have identified our immediate goals as: Becoming an authority on matters REITs through the establishment of a robust information repository, promoting REITs as an investment option in Kenya through events such as the flagship annual REITs conference and lobbying on behalf of members to address policy issues that present an existential threat to REITs. In order to champion these goals, we expanded the main committee and formed 2 sub-committees including: The Membership and Events Sub-Committee and the Policy Research and Publications Sub-Committee.

We will be hosting a Breakfast Forum themed "Practically Growing Real Estate Investments in Kenya" on Tuesday May 21st, 2019 at Park Inn by Radisson, Westlands. During this forum we aim to shed light on the journey of how REITs come to market as well as draw potential REITs issuers together to encourage them to undertake an incubation portal supported by the Association. All are welcome.

We take this opportunity to thank our members and stakeholders at large for the support offered thus far. It is my hope that we will continue working together to grow the REITs sector in Kenya.

Inaugural REITS Conference,

September 2018

The Association hosted its inaugural REITs conference in September 2018, at the Radisson Blu Hotel in Upper hill, Nairobi. The conference brought together approximately 250 delegates from various sectors including regulators, developers, investment banks, advisors, fund managers, trustees, commercial banks, insurance companies, pension funds, administrators and development finance institutions among others. Honorable James Macharia, the Cabinet Secretary for Ministry of Transport, Infrastructure, Housing and Urban Development gave the key note speech during the conference noting that the government was keen on driving the housing and REITs agendas in Kenya through partnerships with the private sector. The conference, which was themed "REITs - Unlocking the Potential of the New Investment Frontier Opportunity in Kenya" attracted international speakers Michael Grupe, immediate past Vice President of Research and Investment Opportunities at NAREIT, Andrew Brooking, a corporate finance executive at Java Capital and Fred Cooper, the Senior Vice President at Toll Brothers. The key topics discussed were the considerations in establishing a world class REIT, Toll Brothers developer experience from a local home builder to a fortune 500 Company and the success factors in the development of the South African REIT market.
